### **Public Hearing**

GLC Site Plan

Mr. Sorgi stated the Site Plan Application was published and mailed on October 22, 2021. The SEQRA had been completed and approved.

He began to speak on the 10 different criteria's ranging from location to landscaping that needed to be met for planning the site, with them all being met.

Resident Maryjane Dash asked if the waste product was going into the Ischua Creek and causing pollution.

Representatives from GLC responded with no contaminants will be going into the creek. There is a Wastewater treatment plant right on site and DEC approved for the filtered water will then go into the creek. The public waste will be going into the Village Sewer System that will be extended to reach the GLC building.

Resident Kim Pfiel was concerned about the safety of the building and the response time from local fire departments.

Representatives from GLC responded that all new safety technology will be in place in the building and if the fire department needs to be called all local departments will be called together.

Mr. Sorj along with the GLC Representatives added a few more items about the building and those are:

- Will be ADA compliant
- Storm water will drain off into two drainage ponds
- The addition of almost double the jobs now will make a huge impact to Franklinville and Farmersville

If the Site is approved the plans are:

- Breaking ground April 2022
- Building shall be up by the end of 2023
- Late 2024 GLC shall be running at full capacity

Councilwoman Heather Stevens questioned Rt. 16 traffic and GLC Representatives replied with:

- DOT has preformed six studies as well as speed studies. As a result, one of the driveways has been rearranged.
- As of right now DOT has not said anything else needs to change.

Supervisor asked the attendees if there were any other questions and asked to close the public hearing.
